What Information We Collect

When you create an account on the BDA BJJ Portal, we collect and store the following personal information:

- Your full name
- Your email address
- Names and ages of any children you register under your account
- Attendance records for you and your children
- Your belt rank, belt assignment date, and attendance since promotion
- Confirmation of acceptance of our waiver agreement
- Any billing-related data, including attendance summaries and invoice status

Why We Collect This Information

We collect this information for the following purposes:

- Billing: Your name and email are required to generate and send monthly invoices based on class attendance.
- Attendance Tracking: We track attendance to calculate billing, monitor progress toward promotions, and maintain class records.
- Waiver Agreement: By registering, you accept the terms of our waiver agreement. If you add children, you accept the waiver terms on their behalf.
- Membership Management: We use your details to manage your membership, communicate with you, and ensure your participation is recorded accurately.

How We Protect Your Information

We use industry-standard security safeguards to protect your personal data, including:

- Google Firebase Authentication and Firestore with role-based access
- HTTPS encryption across all communication with the site
- Secure, access-controlled storage of personal and attendance data
- Internal access restricted to authorized admin staff only

How Long We Keep Your Information

We will retain your personal information for as long as you or your children remain active members of BDA BJJ.

When you notify us that you are leaving the club:

- Your identifying personal data (e.g. name, email, linked children) will be removed upon request, once your final invoice has been issued and settled.
- Attendance and billing records may be retained in anonymized form for internal reporting purposes.

Your Rights Under PIPA

Under Bermuda's PIPA legislation, you have the right to:

- Access the personal data we hold about you
- Correct any inaccurate or outdated information
- Request deletion of your identifying personal information
- Withdraw consent for future data collection and processing

Important Note:

While you have the right to request deletion of your personal information, we may be required to retain certain data if:

- You are an active member or have an outstanding invoice
- We reasonably believe the data may be relevant to a current or future legal matter

In such cases, deletion will be deferred until obligations are fulfilled or risks have passed.

You also confirm acceptance of the waiver agreement and accept responsibility for any children you register.
